Councilpersons Ozuna, Medina and Soules;

We are requesting that each of you set aside time to meet with members of CAPCWFA as soon as possible. We are requesting that you open an official independent investigation into the criminal activity we continue to report. We are requesting that you lift the illegal ban and allow ALL citizens to attend public Council meetings.

We would like to discuss several issues that impact citizens of ALL Council Districts including but not limited to:

- 1. Texas Open Meetings Violations In an effort to hide an ongoing criminal cover-up of long term public/police corruption City Attorney Michael Bernard (brother of White House Social Secretary Jeremy Bernard) and Police Chief William McManus issued an illegal/unconstitutional criminal trespass warning on July 1, 2009 in violation of the TOMA and other laws. They refuse to provide a reason, time limit, public hearing or an alternate avenue to participate in OUR City government process. Their actions violate many laws, the City Charter, the Local Government Code and the TOMA. Thirty months of Council meetings are illegal and ALL city business is voidable under the law.
- 2. Actions of City Attorney Bernard and staff City Attorney Michael Bernard issued instructions for City persons to ignore reports of criminal activity including theft of public funds from ALL citizens. Former Councilman John Clamp received an email from Bernard and turned citizens away from his Council office. City Attorney Michael Bernard is violating provisions of the City Charter that state that he is

duty-bound to prohibit the expenditure of OUR tax dollars that was not approved by voters via the Council/city ordinance. He refuses to perform his duty and enlists others to assist him in this endeavor. ......City Charter - Sec. 142. Limitation on debts incurred. Any debt hereafter contracted by any officer of the city, or by any person on account of the city, the payment of which has not been previously provided for by ordinance duly adopted by the council, shall be absolutely null and void and uncollectible at law or in equity, and it shall be the duty of the city attorney to plead this provision to defeat the collection or enforcement of any such claim or debt

- 3. Actions of Police Chief McManus and staff- Police Chief William McManus and SAPD have ignored several police reports detailing criminal activity and crimes against citizens of San Antonio. McManus and his staff ignore ALL reports from ALL citizens in an effort to assist other corrupt city persons to hide the crimes.
- 4. "Fraud upon the Court", Aggravated Perjury, Subornation of Perjury, Obstruction, etc. by City officials/employees/attorneys - In February 2009 inside the Bexar County Courthouse - 57th District Court- City Attorney Deborah Klein conspired with IT Director Hugh Miller and others to defraud our judicial system and hide decades of fraud/theft inside the City's IT Department. SAPD and other law enforcement agencies ignore police reports and correspondence from numerous citizens in an effort to keep the crimes hidden. Criminals involved in the fraud/theft and ongoing cover-up remain on OUR City payroll with access to OUR money, contracts and other resources.
- 5. Bond and Grant Fraud City persons have submitted fraudulent audits and other documents in an effort to hide three decades of theft/fraud and the ongoing criminal cover-up of the criminal activity. They submitted false information to Federal investigators concerning HUD-OIG case # HL-10-0465 in an effort to hide massive fraud/theft. City persons stated that only \$648 was misspent when in fact tens of millions of dollars was stolen or misappropriated over the past three decades. Bond offering statements contain known false information and deliberately omit material facts in an effort to conceal criminal activity and the ongoing illegal cover-up.
- 6. Acts of Councilman Diego M Bernal Bernal was made aware of the criminal activity in June 2011. 

Citizenss and I provided you with numerous reports of the criminal activity beginning in June 2011 and requested your assistance. 



We have located approximately 1,218 pages which are potentially responsive to your request. Pursuant to the U.S. Department of Justice (DOJ) regulations, 28 C.F.R. §§ 16.11 and 16.49, there is a duplication fee of ten cents per page. The first 100 pages will be provided to you free of charge. In accordance with the DOJ regulations, the FBI notifies requesters when anticipated fees exceed \$25. A rep-resentative of Attorney General Abbott's Office suggested that we contact you.

We filled a Texas Open Meetings Act complaint citing the fact that at least two law-abiding citizens were illegally prohibited from participating in public meetings by San Antonio TX City Attorney Michael Bernard (brother of White House Social Secretary Jeremy Bernard), Mayor Julian Castro (Obama campaign co-chairman) SAPD Chief William McManus and others. U.S. District Judge Rodriguez issued an injunction on Marcin 27, 2013 stating "Defendants are enjoined from enforcing the criminal trespass letter during the pendency of this limitation." Judge Rodriguez cited the fact that the City provided no proof of a physical threat, the lack of due process, the lack of procedural safeguards and a citizen's right to freedom of expression being protected by the First Ameradment. In response to the Judge's ruling the City lifted bans of seven months and forty-five months. Both citizens cite their "whistle blowing" as the reason Bernard illegally banned them in an effort to hide criminal activity including the theft and misuse of 911 and other public safety funds.

Bexas County District Attorney Susan Reed ignored the original TOMA complaint of April 25, 2013 and a follow-up letter of May 14, 2013. In an effort to protect her former Assistant DA – now City Attorney Michael Bernard – Reed and ther office have Ignored reports of public/police corruption, the theft of upwards of \$200,000 by City IT manager lose Medina and city vendor Isabel Gonzaba, no-bid contracts with huge mark-ups steered to "friends", mail/wire fraud, a "fraud upon the court" financed with public funds by Bernard to hide the criminal activity, aggravated perjusy, obstruction, , grant fraud, falsification of government documents, bond fraud, abuse of office, accounting fraud and other crimes.

In an effort to protect City Attorney Michael Bernard and others Reed's office has in the past made faise statements that they had no jurisdiction when State Senator Leticia Van De Putte and Texas Ranger Hank Whitman indicated otherwise (recording of a meeting with Van De Putte where she reviews the reports of criminal activity and Whitman's letters are available for review). Reed's Office made the false statement that no investigation into the reports of corruption was conducted as there was no evidence of wrongdoing while a published statement to the Attorney General, a search warrant, recordings, etc. indicate that an investigation was in fact begun after ADA Barry Elliott and Texas Ranger Whitman saw proof of the criminal activity – especially the four years of theft via "packaled" invoices by Medina and Gonzaba. The investigation was prematurely halted and participants were sworn to silience to hide the criminal activity.

District Attorney Reed's Office ignored many reports of criminal activity but her failure to take action concerning reports of terroristic threats made by supporters of City Councilman Diego M. Bernal to intimidate/scare whistEeblowers put lives at risk. A cursory investigation into the telephone and internet threats would have revealed that the "ringleader" of the group Anonymous/OccupySA whose members communicated with Bernal via middle of the night Facebook texting (documents available) and who then made the threats was registered high-risk sexual predactor Eric Michael King – aka Serpentitis Kingsley. Families including young children remain at risk while DA Reed and her staff look away.

San Antonio TX FBI Agent D. True Brown published a document falsely stating that three separate meetings took place and no wrongdoing by the City was ever discovered. Since 2009 we have asked the FBI for information concerning the dates, times, participants, etc. in these "ghost" meetings. Sooner or later the FBI and DOI must concerde that Agent Brown was being untruthful, there were no meetings and there is proof of an ongoing criminal conspinery inside the City of San Antonio and Bexar County Texas. FOIA case # 1206258-000 is still open. We wait for an answer and again request assistance. Please schedule a meeting with a group of citizens to discuss this criminal activity and provide us with an opportunity to submit sworn complaints.

On September 13, 2010 I met with you and your First Assistant City Attorney regarding John F. Foddrill, who received a letter from your office dated July 1, 2009. As you will recall the letter is also signed by Chief of Police William P. McManus<sup>1</sup>.

The letter states in pertinent part as follows:

1 "you are not to enter or remain on certain city-owned or city-leased property or building. The notice is made oursuant to section 30.05 (criminal trespass) of the Texas Penal Code.

You are prohibited from entering or remaining in San Antonio City Hall...

You are prohibited from entering or remaining in the Municipal Plaza building...

You are prohibited from entering or remaining in that portion of the Public Safety Building occupied by the Information Technology Services Department...

You are prohibited from entering or remaining in that portion of the River View Towers building that is occupied by the offices of the City of San Antonio...

These prohibitions shall remain in effect until you are notified in writing, by someone with authority to act on behalf the City of San Antonio that these prohibitions have been lifted."



During our meeting you informed me that you would withdraw your letter of July 1, 2009 and that the prohibitions would be lifted and that you would send me a letter to this effect in the near future. I still have never received your letter.

This criminal trespass warning has been in effect for twenty two (22) months. If you are reneging on your promise to withdraw your letter prohibiting Mr. Foddrill from coming upon the City property described in your letter then I need to know this. I will need for you to provide me with copies of any documents or evidence you have relied upon for issuing this criminal trespass warning to Mr. Foddrill.
